Happy Spring Daughters!

Have you heard all the BUZZ about Thomas Lunt's presentation on Bees?

Here are a few of the highlights...

Do you like to travel? Did you know every year honeybees are trucked across the US and back from the East coast to CA to pollinate crops such as almonds? Those are some well traveled Bees!

How many food items that you enjoy include tomatoes?

Honeybees are the ONLY insect that pollinates tomatoes.

- Europeans brought honeybees over to the US over 400 years ago.
- We have lost 47% of the insect population in the last 50 years!
- North America has lost about 3 billion birds in the last 50 years!

What can you do to help you ask?



Well, here are a few ideas...

Purchase nonself pollinating native plants to put in your yard to encourage bees, butterflies and birds to habitat on your property. <u>https://www.delawarenaturesociety.org/activitie</u> <u>s/events/native-plant-sale/</u>

Do not buy dyed mulch. Dyes are harmful to the environment. Try pine bark, cedar or Licorice root mulch instead. Leave some leaves under plants as insects like to build homes under them including bees.

Make a resting spot for bees to get a drink: Make a 1:1 ratio of water to white table sugar and place in a small shallow container outside. Change daily to prevent mold.


jigsaw puzzle together. You have to make all the pieces fit in order to make the puzzle work and look good. The same thing occurs when you are researching your roots. Here are a few tips to get you started on your journey.

Your first two starting points are...

 Write down as much information you can find on your birth parents (i.e. birth date and location, marriage date and location, death date and location, burial date and location).

 Next, do the same for your paternal (father's side) and maternal (mother's side) grandparents.

The more information you obtain the "easier" your search will be. However, if you don't have all this information or any of this information don't panic! There are other ways to obtain it. You can get information on your birth parents by obtaining a copy of your birth certificate. If you don't have it already you can obtain one from the vital records office in the state or territory you were born or through a few online search engines like www.archives.org or www.vitalrecordsonline.com. You will need to prove who you are by providing a copy of your driver's license or a non-driver ID card, a passport, or a military ID card. You may also need a utility bill as a secondary means of identification. There is usually a processing fee to obtain a copy of your birth certificate and that fee price varies depending on the state, territory, or country you were born. If you were



born outside the United States to American parent's, you should obtain a copy of a Consular Report of

Birth Abroad (CRBA). This information is obtained when your parents notify a US Embassy or Consulate Office of your birth. If your parents were in the military and did not file for a CRBA then you can contact the hospital in which the birth occurred, the military base operator where your parents were stationed during your birth, or the public affairs office of the appropriate military branch. Once you obtain a copy of your birth certificate it will list your father's name and your mother's maiden name and the locations they were born. Some locations may list state, territory, or country only and others may list city/state or county/state. If "unk" is listed as a location it means whomever supplied the information of the birth didn't know the location the parents were born. If this is the case you can always find out his information as you continue your search. If you were a child born abroad and adopted by a US citizen you will need to know or find out what country you were born. You will not receive a US Birth Certificate but should receive a document proving your birth in this case but will need to contact the nearest embassy or consulate to the country you were born. If the document is written in another language, you may also want to request from the embassy/consulate help with translations.

#### The Bicentennial Celebration of Lafayette's Farewell Tour to America (1824 – 1825)

Lafayette's Farewell Tour saw the 67-year-old last surviving major general of the American Revolution triumphantly return to the country he loved. Both Congress and President James Monroe had invited him with the hope that his visit might reignite patriotic fervor in a politically divided America, fast approaching its 50 th Anniversary.

Lafayette hoped to return to France with the story of a successful democracy. From August 15, 1824 to September 9, 1825, Lafayette covered over 6000 miles by carriage, stagecoach, canal barge, and steamboat, traveling to all 24 exiting states and "Washington City." Everywhere he went and with a renewed patriotism. Lafavette was met with adoration and accolades as the American hero he was.

This presentation will cover the details of Lafayette's Farewell Tour of America, how it will be celebrated in 2024 - 2025, and how everyone will have the opportunity to get involved.

## **RISE AGAINST HUNGER**

On March 12, 2023, Laurie Bottoni-Lorenz participated in an event for Rise Against Hunger at Sussex Central High School. With quidance (and a fun play-list!) the volunteers of all ages ran an assembly-line-style production to fill bags with soy for protein, dehydrated vegetables, seasonings/vitamins, and rice.



Then the bags were weighed, sealed, stamped with a packing date, and boxed for shipping. Community organizations raised money for the materials which cost

\$39,000. Two shifts of volunteers managed to pack 100,000 meals, ready for shipping around the world. This is a growing, annual event. Next year, organizers are hoping to raise the money and



volunteers to pack 150,000 meals!


## A PIECE OF HISTORY

#### Thomas McKean is born

On this day in history, March 19, 1734, Thomas McKean is born. He would be one of the most politically active of the Founding Fathers, a signer of the **Declaration** of Independence, President of Delaware, Chief Justice of Pennsylvania and Governor of Pennsylvania.

**Thomas McKean** was born in Chester County, Pennsylvania to Irish immigrants of Scottish decent. He became a lawyer in the 1750s. Delaware at that time was technically a part of Pennsylvania, but had its own General Assembly. McKean had homes in Philadelphia and in Del aware and was politically active in both.

His first public office was Attorney General for Sussex County, Delaware. He became a judge of the Court of Common Pleas in 1765 and was sent to the **Stamp Act Congress** from

Delaware to coordinate resistance with the other colonies against the <u>Stamp Act</u>. From 1762 to 1776, he was a member of the General Assembly in Delaware and served as its Speaker of the House in 1772.

McKean was chosen as a member of Delaware's delegation to both the First and Second Continental Congresses. He was a prominent advocate of independence from Great Britain and voted for the <u>Declaration of</u> <u>Independence</u> on July 2, 1776. McKean helped write the <u>Articles of</u> <u>Confederation</u> and served as the President of Congress for a few months in 1781, during

which time **Lord Charles Cornwallis** surrendered his army at Yorktown, the event that eventually brought the Revolutionary War to an end.

During the war, McKean participated in the defense of New York City. He also attended Delaware's convention to write its own state

constitution. He wrote virtually the entire constitution in one night and, when it was ratified on September 20, 1776, it became the first state constitution to be adopted after the colonies declared their independence. McKean then served as President of Delaware for a short time when the then current president, **John McKinly**, was captured by the British.

McKean was elected Pennsylvania' s Chief Justice from 1777 to 1799. In this position, he became one of the most prominent shapers of the American legal system, some scholars



believe even more so than the long serving Chief Justice of the US Supreme Court, **John Marshall**. McKean served at the Pennsylvania Convention which ratified the <u>US Constitution</u> and at the convention which adopted a state constitution for Pennsylvania.

**Thomas McKean** was then elected governor of Pennsylvania for 3 terms from 1799 to 1808. He led the way in preparing Philadelphia's defenses during the **War of 1812**, at the age of 80 years old. He finally passed away at the age of 83. His grave is at Laurel Hill Cemetery in Philadelphia.

# 2023 Christina River Watershed Cleanup

## Saturday April 22nd \*Earth Day\* at 8:00 AM

Gliding through rolling hills, farms and forests, large and small towns, the Brandywine, White Clay, and Red Clay Creeks, and Christina River constitute the watershed of the Christina River Basin, before continuing into the Delaware River. **This watershed provides more than 75% of the water supply for residents and businesses in New Castle County, Delaware.** 

The Christina River Watershed Cleanup's mission has always been the removal of manmade debris from within this beautiful watershed, while raising public awareness for pollution prevention. Since the Cleanup began in 1992, more than 360 tons of tires, appliances, household items, and other trash have been cleared from within the watershed.

A DAR team will meet at the Hale Byrnes House, 606 Stanton Christiana Rd, Newark, DE 19713, at 8:00 AM (because of the tides) to pick up trash until about 11:00 AM. It will be led by Sarah O'Donnell, State and Cooch's Bridge Conservation Chair. This event is **rain or shine** so dress for the weather and wear boots. Trash bags, some tools and gloves will be available, but you may want to wear your favorite garden gloves.
